Arrangement between CEPT administrations concerning the coordination of the frequency assignment of stations in the 1452-1492 MHz frequency band in the mobile (except aeronautical mobile service) and fixed services in respect to Broadcasting-Satellite Service

## **Preamble**

The representatives of CEPT administrations¹ (hereinafter referred to as the Parties) have concluded this Arrangement concerning the coordination of frequency assignment of stations in the mobile (except aeronautical mobile service) and fixed services in respect to Broadcasting-Satellite Service (BSS) in the frequency band 1452-1492 MHz (hereinafter referred to as the Arrangement) with the aim of minimizing the number of countries involved in coordination process. This Arrangement can be used by the Parties as an agreement obtained under ITU Radio Regulations provisions No. 9.6 and 9.19 procedure with respect to BSS.

## 1 Use of frequencies

1.1 The Parties agree that frequency assignments do not require coordination with respect to BSS in the frequency band 1452-1492 MHz as ECC/DEC/(13)02 withdrew the ECC/DEC/(03)02 of 17 October 2003 on the designation of the frequency band 1479.5-1492 MHz for use by satellite digital audio broadcasting systems in CEPT.

## 2 Revision and cancellation

- 2.1 This Arrangement may be revised at any time on the initiative of any Party with the consent of the other Parties.
- 2.2 This Arrangement may be cancelled by a mutual decision of all Parties on terms and conditions adopted by the Parties or any Party may withdraw from the Arrangement notifying the other Parties on its intention at least six month before.

## 3 Entry into force

- 3.1 This Arrangement shall come into force for the Parties on the date of signing it.
- 3.2 This Arrangement has been drawn in English and agreed by correspondence.
- 3.3 The list of Parties is given in Annex of this Arrangement.
- 3.4 The Electronic Communications Office of Latvia acts as a point of contact for collecting the signatures from Parties of the Arrangement (i.e. managing Administration of the Arrangement).
- 3.5 This Arrangement has been drawn in one hard copy and its original is stored by the Electronic Communications Office of Latvia.
- 3.6 After collecting the signatures from Parties the Electronic Communications Office of Latvia will send scanned copy of the Arrangement to all Parties which signed the Arrangement.
